Roll was called and the minutes for the March 8, 2023, and Special Called April 5, 2023, Board Meeting minutes were approved as presented.

Salary recommendations for Fiscal Year 2024 were presented as an Added Agenda Item.

Reports provided from the following:

In the absence of Treasurer Lynn Claxton, Director Stevens reported that the Financial Report for February reflects 85.55% of the budget is expended. Fiscal Year 2024 Budget Packets are not available to date. Maintenance of Effort appears to be on target.

Attached as page 4 is the Director's Report. She also shared that a high school student is now joining Director Stevens and IT Specialist Kathy Pack on WCDT radio on Wednesdays. MyLibro, an app, is in the research stage that will combine all the library's digital services. The Franklin County Library Foundation will soon hear requests from the library for library seating and/or shelving for the Juvenile Library.

For Budget Committee Chair Lynn Claxton, Director Stevens shared the Fiscal Year 2024 Budget Packet is not available to date. The Budget Committee met and used this year's budget to prepare. A completed Fiscal Year 2024 Budget will be sent to the board as soon as it's available.

Director's Report May 2023

As the end of this fiscal year is drawing near, I am confident we'll have served around 70,000 visitors with each person averaging at least 1.5 items. The FCL Team will have answered more than 6,000 reference questions! These numbers do not necessarily reflect the many patrons that use the library virtually whether to check out a book, movie, magazine, or other digital media, or to visit one of the databases available like the Tennessee Electronic Library. As one customer said lately as she and her family prepared to take advantage of a beautiful day to walk around the library's lower parking lot, "You can do much more at the library besides reading!"

Speaking of digital resources, we have now added Flex Borrows to the hoopla platform. Patrons gain an additional 5 checkouts to the 5 with the Instant program. The Flex program does just what it says. It allows the library to purchase one copy one user titles as with Libby. Cardholders will have access to a greater selection of eBooks and eAudios. An app is also in the research stage. MyLibro will provide a true one-stop-shop experience where most, if not all, of the digital services FCL provides are accessed without ever leaving the app.

The Elected Officials' Lunch and Learn on April 27th during National Library Week provided an opportunity to share FCL services, programs, and the vision for the future. Attendees were: County Mayor Chris Guess; Commissioners Bill Anderson, David Eldridge, Lydia Curtis Johnson, David Kelly (also Estill Springs Mayor), and Tyler Bauer; Register of Deeds Denise Marshall and Deputy Register Nancy Ringer; County Clerk Tina Sanders; Winchester City Councilwoman Barbara Lucas; Chairman of the Board Kelly Doyle and Co-chairman Carl Goodman; and Friends of the Library President Kelli Riley. It is with great appreciation these are mentioned for the support shown.

Throughout the school year the library hosts hundreds of Franklin County students. Several classes from Clark Memorial and Cowan came recently for special programs geared toward each individual group. For some of the students, this was their very first visit. Some students also got a library card. The Second Graders were in awe. The exact effect we hope for—sparking wonder, imagination, and creativity! We'll see many more as May ends and Summer Reading begins. This year's theme, All Together Now, encourages participants to serve one another and the community in many ways like volunteering, helping a neighbor, shopping locally, etc. FCL will host a first-time Adult Summer Reading Program as well. All readers of these programs may earn prizes for challenges met thanks to local sponsors like Bennett's Pharmacy and Nissan.
