The Franklin County Library Board of Trustees met on July 13, 2022, at 4:00 PM at the Franklin County Library with the following present: Dave Van Buskirk, Chairman; Kelly Doyle, Co-chair; Lynn Claxton, Treasurer; Carl Goodman, Mickey Hall, and Portia Vaughn, Trustees; David Eldridge and Bari Beth Lowndes, Trustee elects; Tina Stevens, Director; Kate Huddleston, Regional Library Director.

Roll was called and the minutes for the May 11, 2022, Board Meeting and the June 20, 2022, minutes were approved as presented.

Reports provided from the following:

Treasurer Lynn Claxton reported that the interim financial report for June revealed approximately 88% of the budget was expended and the library met Maintenance of Effort.

Attached as page 4 is Director Tina Stevens' report.

Attached as page 5 is the Regional Library Director's report. Kate Huddleston also added that the Trustee Workshop is at Brentwood Library this year on October 4. More information will follow soon.

Building and Grounds Chair Portia Vaughn raised awareness to the digital sign issues. Director Stevens shared that a repair person is difficult to find locally. A new sign may be needed.

Long Range Planning Committee Chair Lynn Claxton submitted the Fiscal Year 2023 Long Range Plan and it was approved as presented. She mentioned a goal to improve readability was met.

On behalf of the Expansion Committee, Director Stevens stated the Franklin County Finance Committee intends to recommend the 2<sup>nd</sup> Ave. SE, Winchester, property to the County Commission with two contingencies: an appraisal and a geotechnical survey with a purchase price of \$340,000 comprised of \$276,923 from local government and \$63,077 from the library. County Attorney Ben Lynch will be consulted to present a formal counter offer to the sellers if the recommendation passed Commission on Monday, July 18.

Personnel Committee Chair Mickey Hall reported the Library Director's performance review went well. He shared the board is happy she is here. She's doing her job very well. Stevens is hugely successful in community outreach, communication, and continues to grow her education as well as the staff.

Director's Report July 2022

Oceans of Possibilities Summer Reading is going well and registration remains open through Friday, July 29<sup>th</sup>. To date, there are approximately 200 children participating. Summer readers may register online or inperson. With Readsquared, an app that encourages reading through games and challenges, participants track progress. To earn physical prizes, readers sign up at the library. A Grand Summer Finale is also planned for Friday, July 29, from 2p to 6p at the Winchester City Park. Commencement begins with the Stand Tall Trail Tale Grand Opening at 2p. Festivities include a water slide, several water games, food trucks, many community partner booths, Touch a Truck, and prizes. Also, by way of the Partnership for Education and Enrichment in the Community (PEEC), two camps in July are offered: Oceans of Possibilities for elementary students and Hidden Treasures for middle school and up, including adults. The Friends of the Library teamed up with the Board of Education once again to offer professional development for Franklin County teachers. There will be two day-long sessions on the 19<sup>th</sup> and 20<sup>th</sup> hosting 12 teachers for each. Lunch is provided by the Friends at Walnut Hill. With Kiwanis, the library is hosting an event for school librarians in August to meet some local authors and pick up free books, too. FCL is busier than ever!

The new study/testing room is installed! Thanks to the American Rescue Plan Act Grant that took the place of the annual Tech Grant, we have this gem. It is virtually sound proof and available for proctored tests such as the Boating Exam we regularly schedule or customer and staff use. We also installed new tables in the Young Adult area that were a gift from the Shelbyville Library. Thanks, Dave Van Buskirk, for delivering those to us! Melissa, a local teacher said, "Thank you!" That area sees a lot of activity.

Our online presence continues to expand. FCL is Tiktok famous! Author Jeff Bishop, <u>A Heavy Dose of Allison Tandy</u>, sent a letter to say he found us and hoped he'd be added to our page. Facebook reaches as far as Ghana, Africa, France, United Kingdom, Honduras, and Germany. I guess we are now a global library! Our most popular Facebook post was the AM Rotary donation for the Trail Tale. Instagram is gaining more followers at 556. We are also on Youtube, Snapchat, and Twitter. Show your support by liking, commenting, and sharing!

To ensure the team at FCL are prepared to do a job well-done, a new training plan is doing well. Management staff work diligently to identify areas to maintain and strengthen, then offer at least an hour session monthly on these topics. The plan works to ensure also that Minimum Standards are met along with Maintenance of Effort as a particular number of credit hours for continuing education are required. The FCL team are proud to serve Franklin County with a smile! Homelessness training and de-escalation tactics are paramount currently. The team are confronted regularly with the issues surrounding homelessness, mental illness, and drug abuse. With deepening concern, more training and awareness is needed as these are part of the many aspects of public library service. A proactive approach is employed by seeking more knowledge and understanding, and drawing upon community partners such as the Prevention Coalition, Salvation Army, churches, and local law enforcement.
